# Coding Manual - Daph-Diff v2.1

Ref. : Daph\_Diff\_D056-mn/111108

This manual is intended for persons who will collect and code (index) useful information for input into the Directory Daph-Diff.

1 > Goals of the Directory Daph-Diff:

- Gather information on the contact information of organisations linked to the European DAPHNE programme in the 27 Member States (EU27). We are collecting information primarily on:

- DAPHNE project leaders since 1997,
  - project partners,
- large NGOs national and European who are active in the field of DAPHNE,
- participants of large international conferences on this field;

then, secondarily we are also collecting information, without being exhaustive on:

- European researchers who have published in this field (particularly in universities),
- ministries and national public service organisations linked to this field,
- the most important written media organisations (10).

- The two main uses for this directory are: searching for project partners, assistance for dissemination of project results.

#### 2> Directory structure:

- The aim of the directory is to make available to the DAPHNE community the contact information (email, telephone, postal address) of major actors in the DAPHNE field. The information collected must be valid, pertinent related to the objectives (no qualitative judgment) and if possible exhaustive.

- The organisations selected must be ethically in line with the DAPHNE activities (no organisation which has goals or activities contrary to the programme).

- We defined 3 levels of description: 6 obligatory variables present in the reduced form (denoted with a \*), the reduced form and the complete form.

## 3> Thesaurus:

- Indexing with the assistance of the thesaurus is an essential part of the Directory which responds to two principles: to be detailed enough to allow for selection of actors pertinent to a search, but not to be too detailed that too few organisations correspond.

- It is the indexing which will give value to the Directory, even more so than the completeness of the Directory. Therefore indexing is extremely important.

- The thesaurus labels correspond to a different method: to conserve the compatibility with the thesaurus present in the Toolkit DAPHNE (version 2005), while introducing evolutions in the thesaurus by adding, for example, new fields of activities.

- We are at the 2.1 version of the thesaurus (October 2011, after the general meeting). This thesaurus could still evolve somewhat but most likely not profoundly. We ask the coders to provide us with comments on usage or improvements for the thesaurus (e.g. labels to modify, eliminate or add).

- The collection of information is made essentially on the Internet.

- We are looking to capture a broad number in the first phase of collection by collecting a maximum of data on organisations related to the field of DAPHNE.

- We are careful not to introduce organisations whose activities are contrary to the goals of the DAPHNE programme.

- We do not lose time trying to fill out a complete file, as we prefer to first collect a large number of organisations and then propose to the organisations to complete the information themselves.

- We give priority to the lists of European networks in the different areas that allow an automatic data collection and provide direct information on the EU27 (e.g. Separated Children in Europe).

- We also incorporate existing directories (e.g.: Directory from Wave). We can contact these organisations to ask for their consent in incorporating their directories into the Daphne Directory.

- Currently we are able to collect information in FR or EN.

- When we want to add a list that is rather long (> 20 organisations) and is well structured, it is possible to have this list automatically updated (see with CM).

- An elimination of doubles will be done at the end of the data collection process.

- When working on data collection in a country in which we do not understand the language, to assist you, use the function *'translate this page'* from the Google search motor.

- We have published a document "Some methods to look for a structure within Daph-Diff directory" (D054).

### 5> Coding principles:

- The goal of indexing is to link information during a search. Thus when selecting « Domain Action « = sexual violence **and** « Target population » = children », one will obtain organisations dealing with sexual violence related to children.

- Check that the organisation is not already in the database before creating a new file.

- Clearly, we do not add associations or partners which no longer exist;

- Code « Other » when there is not enough detailed information for the domain action;

- Code only the essential information. The files will be completed afterwards, either by the organisations themselves or by us;

- Only EU27 (no Norway, Turkey, etc.) and international organisations.

- One can select as many « Domain Action » fields as necessary. One must choose at least one domain.

- One can select as many « Actions » and « Target population» as necessary.

- Use the last known address in case of change of address.

- The data collection languages are English and French. We will see at the end of the project if problems arise regarding translation of the contents.

- Search for an email for the contact person and for the organisation. The majority of the files will perhaps be without an email for the contact person. If we have a personal contact that should be indicated as it is more effective when sending an email.

- If you cannot find the address of the organisation or want more details about its activity you may want to search the *Activity report*.

- The fields *Name of organisation* and *Name of international organisation* should be completed as follows: in the first field place the name of the organisation in its original language. In the second field place its name in English. If the name of the organisation does not exist in English, repeat the name in its original language.

- The abbreviation of the organisation is placed in the field 'Abbreviation'. Place the full name in the field *Name of the organisation* e.g.: Children's Rights Alliance for England and afterwards add the abbreviation at the end: CRAE.

→ As soon as we find an existing list which is pre-formatted on the Internet, select it, assign general key words to it and send it to CM and MN for an automatic collection process.

The goal of the current phase is to simply capture the minimal information for the largest number of organisational files.

#### 6> Objective for number of data collected:

Given the French example we can make an initial projection based on a proportional basis for EU27. For France, apart from DAPHNE partners we found:

- NGO: approximately 80 organisations
- Ministries: 10
- Journalists: 10+10
- Researchers: 10

for approximatively 120 organisations. For the EU27 this would yield 120/63x500 = 952 organisations *a minima*, but of course there are differences in country sizes. The smaller countries nonetheless all have ministries of health, social affairs, etc. For a maximum number we would have

120 x 27 EM = 3 240. This provides us with a number between 2 000 and 3 000 organisations, plus DAPHNE partners (800 projects with 3 partners on average = 2 400 partners), with numerous doubles between projects and with some NGOs already present elsewhere.

- Given this information a directory of about 3 000 to 3 500 addresses appears doable.

- At the moment we have approximately 1600 organisations (end of September 2011) but there are many doubles and certain organisations are still without emails:
